

# A Message from the PRO EUROPA CHRISTIANA FEDERATION to the Pro-Life Movement

#### Let's Be Consistent!

On the occasion of Brussels' 3rd March for Life and of the second European Week for Life at the European Parliament, the PRO EUROPA CHRISTIANA FEDERATION (FPEC) joins its voice to that of the growing European pro-life movement in a loud cry of protest on behalf of innocent human life — life that has no voice but ours. In the heart of the EU institutions, our cry will echo the silent scream of millions of European babies who are massacred in their mother's womb.

We are united in the defense of the defenseless and the protection of unborn infancy. We advocate the cause of those who are the victims of abortionist tyranny, medical cynicism and State hypocrisy.

However, we must not fool ourselves—the stakes are too high! We will never win the fight for life unless we attack the **Culture of Death** at its roots. To be truly and consistently pro-life, it is not enough to oppose abortion. We must also combat:

## \* Moral permissiveness

Fornication and adultery break the sacred bonds that bind human sexuality to procreation and the family. Abortion is the ultimate guarantee of the sterile, lifelessness of sexual freedom: the utter and inconsequential carnal pleasure of "free love," devoid of the responsibility and commitment of marriage. Pope Benedict XVI declared in March 2012: "The human and Christian dignity of procreation, in fact, does not consist in a 'product,' but in its connection with the conjugal act, the expression of the love of the husband and wife, of their union that is not only biological but also spiritual. The instruction 'Donum vitae' reminds us in this regard, that by its 'intimate structure, the conjugal act, while most closely uniting husband and wife, capacitates them for the generation of new lives, according to laws inscribed in the very being of man and of woman' (n. 126)."

Since sexual immorality severs the marital act from its divinely ordained purpose, to defend the sanctity of life we must uphold the sacred covenant of marriage.

# \* Contraception

Contraception-on-demand logically leads to abortion-by-choice. Couples who practice contraception are far more likely to resort to abortion in the case of an unplanned pregnancy as a means of post-conception birth control. In fact, most modern contraceptives are abortifacient, i.e. they abort the unborn child. As Pope Paul VI proclaimed, in his life-affirming encyclical *Humanae Vitae*, "Each and every marriage act must remain open to the transmission of life."

Since abortion thrives on the contraceptive mind set, to oppose the slaughter of abortion effectively we must oppose the anti-life mentality of contraception.

## \* Homosexuality

Besides paving the way for abortion and the break-up of the family, the contraceptive mentality promotes the tolerance—even acceptance—of homosexuality.

As the Congregation for the Doctrine of the Faith warns:

"At the present time there are those who, basing themselves on observations in the psychological order, have begun to judge indulgently, and even to excuse completely, homosexual relations between certain people. This they do in opposition to the constant teaching of the Magisterium and to the moral sense of the Christian people.

(...) But no pastoral method can be employed which would give moral justification to these acts on the grounds that they would be consonant with the condition of such people. For according to the objective moral order homosexual relations are acts which lack an essential and indispensable finality. In Sacred Scripture they are condemned as a serious depravity and even presented as the sad consequence of rejecting God. [cfr. Rom 1, 24-27; 1Cor 6, 10 and 1Tim 1, 10]." Margaret Sanger, the founder of Planned Parenthood, advocated "voluntary association" between sexual partners. Abortionists are consistent when they demand homosexual "rights," for nothing can be more diametrically opposed to the fertility of life than the sterility of this unnatural union. Since homosexuality mocks life, the family its protector, and God its Creator, to

### \* Euthanasia

If man does not defend all innocent human life as sacred and inviolable, no man's life is safe. Just as the defenseless babe in his mother's womb is sacrificed to the self indulgence of our death-worshiping culture, the lives of our infirm, impaired, and aged fall victim to the same false gods.

As Pope John Paul II warns, "Further delays and negligence could result in the suppression of an incalculable number of human lives and in a further serious degradation of all society to still more inhuman levels."

Since the abortion holocaust inevitably leads to the euthanasia holocaust, to defend all innocent human life we must oppose abortion, infanticide, and euthanasia without compromise or exception.

## \* Conclusion

To be pro-life, we must combat moral permissiveness, contraception, homosexuality, pornography and euthanasia with the consistent and constant vigilance with which we oppose abortion.

As already Pope John Paul II reminded us, "Faithfulness is consistency to live in accordance with what one believes; to adapt one's own life to the object of one's adherence. To accept misunderstanding, persecution, rather than a break between what one practices and what one believes: this is consistency." May Mary, our Mother, the living example of faithfulness to Christ, help us bear consistent witness to God's gift of life in all we do!
